An Active member must attend at least four Board meetings during the 12 months prior to the current Board meeting.

If an Active member is not represented at two meetings in a row, then they lose the voting privilege. The right to vote is regained at the beginning of the third meeting attended.

An Inactive member is one who has not attended at least four Board meeting during the 12 months prior to the current Board meeting. When they attend two board meetings in a row, they are automatically restored to active status at the beginning of the third meeting attended.

Failure to attend a Special Board meeting does not affect a parish's Active/Inactive status.
